Section 4 – First Aid Measures

Eye Contact: In case of eye contact, check for and remove any contact lenses. Immediately irrigate eyes with plenty of running water for at least 15 minutes, keeping eyelids open. Seek medical attention.

Section 6 – Accidental Release Measures

Accidental Release: This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern.
